**Dear Members of Congress,**

As officials entrusted with conducting, funding, or otherwise supporting local, state, and federal elections in jurisdictions across the country, we write to encourage you to include critical funding for election infrastructure in the infrastructure bill Congress will consider this year.

If you don't think about election administration day in and day out as we do, you may not realize that the systems, equipment, and facilities we need to administer our country's elections *are* infrastructure. In fact, the Department of Homeland Security designated election infrastructure as part of the existing Government Facilities critical infrastructure sector in 2017.

While that designation is important, it doesn't solve the serious funding challenges facing most election offices. To be clear, these challenges have only grown in recent years—from safeguarding databases from bad actors to maintaining equipment that is growing more and more outdated. And as with most challenges our communities face, the pandemic only added to the problem.

**As Congress considers an infrastructure bill, now is the time to make investments in modern and secure election infrastructure of \$20 billion over 10 years.**

This public funding will give local election offices the ability to modernize and secure equipment, and the certainty to plan and execute professional, accurate elections with integrity for voters for years to come. Please make sure to include funding for secure elections in the infrastructure package.
